

# Letter to My MP: Addressing Unchecked Profiteering and the Human Cost in the UK

Rising Rents, Legislative Inertia, and the Erosion of Social Values

Dear Dan Norris,

I am writing to you as a concerned constituent who is increasingly troubled by the state of profit-driven practices in the United Kingdom, particularly as they relate to the basic human need for shelter. The delay in implementing protective measures for tenants and curbing excessive profiteering is therefore not a matter of capability, but of choice and priority.

- Raise these issues in Parliament and press for urgent debate and action on rent control, tenant protections, and the regulation of property investment.
- Challenge the narrative that slow legislative change is inevitable, highlighting examples where rapid action has been possible when politically expedient.
- Advocate for a new approach to housing that places wellbeing above profits, community above speculation, and people above all else.
